

Research Action Awards Instructions for Applicants

Closing date for applications is Monday **26 August 2019** at 5pm AEST. Please read the instructions carefully before completing the Application Form. Late or incomplete applications will not be accepted.

About the Sax Institute

The Sax Institute aims to improve health and wellbeing by driving the use of research in policies, programs and services. We work with our members, drawn from public health and health services research groups and their universities, to achieve this aim.

About the Research Action Awards

The Sax Institute Research Action Awards recognise individuals whose research has significantly impacted on policy, programs or service delivery. Up to three Awards will be granted and each winner will receive a certificate and prize of \$5,000.

Eligibility criteria

Applications are open to individuals who:

- Work for an Ordinary Member organisation of the Sax Institute – please see Appendix A for our list of Ordinary Members
- Have up to 15 years' postdoctoral or equivalent experience
- Are able to provide evidence that their research has had an impact on health policy, programs or service delivery in the past five years.

Applications must describe research that the applicant led or played the leading role. The research in question may be either a specific research project, or a specific and discrete element of a wider research project. In situations where the research project was undertaken by a team, the applicant must clearly identify the aspects of the program or project they led.

Policy, programs or service delivery impact can be in the government, non-government or private sectors.

Application requirements

It is the responsibility of the applicant to ensure that the application is complete and accurate. Applications must be completed using the proforma provided by the Sax Institute. The completed Application Form including required attachments (such as documentary evidence of impact) should be merged into a single pdf document (max size 10MB) and emailed to communications@saxinstitute.org.au Multiple files or files in other formats (such as Word documents) will not be accepted. Files should be named using the following convention:

Firstname_Surname_2019_Research Action Awards (for example, Jo_Smith_2019_Research Action Awards).

There must be no changes to the headings, formatting or removal of text fields or instructions contained in the Application Form or Verification Form.

Electronic applications must be submitted to the Sax Institute by 5pm (AEST) on **26 August 2019**. Applications that are late or do not adhere to the instructions will not be considered. Hard copy (paper) applications will not be accepted.

Assessment of applications

Applications will be assessed by an independent Assessment Committee consisting of international and national leaders in the field. The Committee will be chaired by Professor Trish Greenhalgh OBE, University of Oxford.

Applications will only be considered where evidence is provided that the research has had an impact on policy, programs or service delivery in the past five years. Documentary evidence and verification by a research user (defined as an independent third party who is a policy maker, program designer, service provider or similar) must be provided and will be used to help assess the extent to which the research achieved impact. Applications will be ranked according to:

Contribution (40%)

The contribution of the research findings to policy, programs or service delivery (that is, would the policy or practice change have happened anyway? Did the research make a big or small contribution?)

• Significance (40%)

The significance of the impact of policy, programs or service delivery on health or health services (for example, to what extent did the research have positive effects on quality of life or cost efficiencies?)

 Research translation activities (20%) What efforts did you make to secure policy and/or practice change? What did you do in addition to conducting and publishing the research to ensure your research had an impact? If appropriate, identify how your activities differed from those of the wider research group.

Award ceremony and media coverage

Successful applicants will be notified by early November 2019 and will receive their award at a ceremony on Tuesday 26 November 2019 in Sydney.

The Sax Institute will publicise the Award winners to showcase their achievements. Winners are encouraged to participate in media activities.

Completing the application

Section 1: Applicant details

- Organisation: Please identify which Ordinary Member organisation of the Sax Institute (refer Appendix A) you are employed by.
- Level of experience: Please indicate how your level of experience meets the eligibility criteria.

Year your PhD was conferred: Applicants
with up to 15 years' postdoctoral experience
are eligible for the Award. However, the
Assessment Committee will consider
exceptions where individuals have similar
experience – for example, an interrupted or
part-time research career or no PhD but
relevant research experience. If you wish to
be considered as an exception, please
provide justification for the equivalence of
your experience.

Section 2: Details of your research and its impact on policy, programs or service delivery

- Describe your program of research including brief comments on purpose, background, aims, method, findings and implications.
 Please provide a brief description of your research work referencing the above areas.
 Please note the 3000-character limit.
- List up to three of the most significant articles or other publications that have been published about this research. Peer-reviewed papers, reports, policy papers and similar are acceptable. Please include a copy of each publication at the end of your Application Form and combine your application materials into a single PDF document. For large documents, attach the front page of each and relevant chapters/pages.
- Describe the impact on policy, programs or service delivery that occurred as a result of your research. Please provide details that will help us understand the nature and scope of this impact. In your response, please include:
 - 1. A description of the impact on policy, programs or service delivery.
 - The contribution of the research project or program to the policy, programs or service delivery (i.e. Would it have happened without your research? Did it make a major or minor contribution to the overall impact?).
 - 3. The **significance** of the impact of policy, programs or service delivery on health or health services (e.g. wellbeing, quality of life, mortality, cost efficiencies of service provision, number of people affected).
 - 4. The **research translation activities**. What efforts did you make to secure policy and/or practice change? What did you do to ensure your research had an impact? How did your activities differ from those of the wider research group?

Please note the 3000-character limit for responses.

Section 3: Verification

Two forms of verification need to be included in your application:

- 1. **Documentary evidence** of the impact of your research (e.g. key reports, discussion papers, publications or articles, presentations, and/or policy documents). Please attach all listed documentary evidence at the end of your Application Form when combined into a single pdf document. If the document is lengthy, please only include the front page and relevant chapters/page(s).
- 2. A Verification Form, to be completed by a research user (defined as a policy maker, program designer, service provider or similar) who can independently confirm that the research has had an impact on policy, programs or service delivery. Send a copy of your application to the verifier prior to the completion of the Verification Form. Please organise for this Verification Form to be completed and sent directly to the Sax Institute by 5pm, 26 August 2019.

Note:

- A verifier should be an end user or individual who can comment on the impact of research, including the significance of it and the applicant's personal contribution to it. This is preferable to a research colleague or PhD supervisor.
- Verification reports that demonstrate a greater degree of independence will be viewed favourably.
- Where research has been delivered overseas, the verifier should be located in the country where the impact is being realised
- It is your responsibility to ensure that the nominated research user completes and submits the Verification Form DIRECTLY to the Sax Institute via communications@saxinstitute.org.au before 5pm, 26 August 2019. Any Verification Form received after the closing date will not be considered.
- Only those applications that provide verification will be considered by the Assessment Committee.
- Verification Forms sent from applicants to the Sax Institute will not be considered.
- Only one Verification Form per applicant will be accepted.
